### 12:50 Steering Committee update (Mark, Anat, Heather, Lily, Carl)

Steering committee meets most Mondays, not this week.

APS upgrade has also been pushed back 10 months, possibly coinciding with the timeframe of the award of new COMPRES/GSECARS organization.

# 1:38 APS upgrade (Mark)

Announcement at APS users' meeting that APS upgrade postponed 10 months. Ring goes down 1 year starting April 17, 2023. No impact on cost or completion time. Most of slip due to delays from vendors. Beamlines expected to be back to full capabilities ~3-6 months after beam comes back.

NSLS II is accepting limited in person experiments. APS started to accept in-person users 2021-1. Needs at least 1 month lead time for DOE approval of special justification for on-site work. 2-3 in person users at GSECARS 2021-1, aiming for increase in next cycle.
