Carl consulted Robert Detrick, the president or IRIS on the NSF announcement that SAGE and GAGE will merge. The two projects will need to be covered by one proposal with the management structure focused on efficiency, streamlining and cost savings. GSECARS and COMPRES have been asked by NSF IF to consider the pros and cons of a merger, so the SAGE/GAGE merger provides some useful information.
